# TRANSITIONS CONTRACT MODIFICATION EIGHT

# GOODWILL INDUSTRIES (DUNS: 030562425)

The contract #ISY-2018-06 is modified according to the text and revised budget below. The contract is extended for one additional year from July 1, 2020 to June 30, 2021. All other provisions of the original contract remain in force except as specifically changed by this modification.

The Indirect Cost line item is calculated at the 10% de minimis rate. The base is based on the Modified Total Direct Costs (MTDC) model. MTDC means all direct salaries and wages, fringe benefits, materials and supplies, services, travel, and subawards and subcontracts up to the first \$25,000. For the budget above, Indirect Costs equals 10% of Salaries, Benefits, Materials and Supplies, and Travel (\$123,142.00).

### **WORK PLAN**

- Goodwill expects to serve approximately 85 students. Success rate for employment or post-secondary educational training 70%.
- The Transition Services Specialist job title has been changed to Transition Services Case Manager. Duties and responsibilities remain the same.
- Classes will be held at the GED provider's building and feature topics such as motivation, time
  management, conflict resolution, financial literacy, and career development. There could also
  be an opportunity to host some of these classes on site at our Goodwill Commons location.
  Yearly program "kick-off" celebrations will also be provided to give students an opportunity to
  socialize and connect with each other, which will also aid in program engagement. The
  Transition Services Case Manager will also be able to meet youth in the community one-on-one
  if they are unable to make it to group events.
- The Transition Services program will be staffed by one full-time Case Manager who is 100% allocated to the program and funded through this grant. In addition, upon adding Spoon River College, another full-time Program Specialist will be allocated at 70% to the program to provide administrative and clerical support. A full-time Program Manager will be allocated at 40% to manage the program, grant outcomes, and the two other staff members. The Assistance Director of Program Services will be allocated at 20%.
- Incentives will be given in the form of Walmart gift cards, up to \$400 in gift card incentives per student. Assistance for specific student needs (relating to employment, schooling, or basic living needs) such as, pre-paid gas cards, bus passes, grocery gift-cards, food cards to local fast food establishments, Goodwill clothing voucher, work equipment or uniform purchase, voucher for driver's education, book-store voucher, voucher for tuition assistance, and training/testing fees, may also be provided on a case by case basis. All records and proof of attainment must be submitted in person for documentation purposes with signatures from both the student and Transition Services Case Manager.
- Incentives will be awarded for the following accomplishments and activities: Program
   Participation/Engagement; Placement & Retention in Employment, Education or Military;

   Attainment of a Certification or Diploma; and Career and Work Readiness Skills Attainment
- Incentives may vary among GED programs, so that Goodwill Transition Services does not duplicate any incentives provided by Career Link or the GED providers. Incentive Tracker documents are attached to this contract modification.
